

NOTIFICATION

In exercise of the power conferred by Clause (7) of Section 2 of the Code of Civil Procedure, 1980, the State Government hereby appoints **Sri Dilip Ch. Nath**, Ld. Advocate, High Court Bar, Agartala, Tripura as the **Addl. Government Advocate**, to conduct cases or appeals in the High Court of Tripura for and on behalf of the State of Tripura or such other cases or matters, time to time assigned to him by the State Government.

2. He shall be entitled to retainer fees and such other fees as admissible under the L.R's Manual and such other order (s) revising the rate of fees, issued by the Government in the Law Department, time to time.
3. No consultation or perusal fee will be allowed to the Addl. Government Advocate, High Court of Tripura, in a case in which the Government is a party. No fee will be allowed for adjournment of any case in the High Court of Tripura.
4. The Advocate, so appointed shall submit joining report to the Law Department immediately after joining.
5. His appointment as the Standing Counsel for Taxes vide this department's Notification No.F. 5(11)-Law/LR-II/2010/ 5737-87 dated 12-09-2016 is cancelled, but he is to continue the works, as such, till the post of Standing Counsel of Taxes is filled up by another one.
6. This will take immediate effect and will remain in force until further order to be issued in this regard.
