NOTIFICATION

**WHEREAS** by a Notification of the Government of Tripura in the Law Department No.F.2 (8)-LAW/COM/2019/4933 dated 13<sup>th</sup> December, 2019, the State Government appointed a Commission of inquiry consisting of a single Member, namely, Hon'ble Mr. Justice S. C. Das, Retired Judge of the High Court of Tripura to enquire into the matter of death of Happy Debbarma S/o.Shri Dinesh Debbarma & Smti Rajmala Debbarma of village Juricherra under Kumarghat Sub-division, Unakoti District;

**AND WHEREAS** it was specified in the aforesaid Notification that the Commission would complete its inquiry and submit its report alongwith recommendations, if any, to the State Government on or before the 31<sup>st</sup> day of January, 2020;


**AND WHEREAS** the Commission vide note dated 29.01.2020 communicated to this Department on 31.01.2020 observed that it was not possible for the Commission to complete the inquiry within such a short time and thus the Commission had desired for extension of the term of the Commission of Inquiry for six months more to complete the inquiry;

**AND WHEREAS** the State Government, having regard to the circumstances, is satisfied that the term of the Commission is required to be extended for submission of its complete report to the State Government;

**NOW, THEREFORE,** the State Government hereby extend the term of the Commission for six months with effect from 1<sup>st</sup> February, 2020 and the Commission shall complete its inquiry within this period and submit report to the State Government with regard to the terms of reference as specified in the Notification No.F.2(8)-LAW/COM/2019/4933 dated 13<sup>th</sup> December, 2019.

This Notification shall come into force with effect from 1<sup>st</sup> February, 2020.


