The Asst. They shall not be entitled to any fee for adjournment of any case. Their appointment shall be subject to other terms and conditions under the LR's Manual and any circular, memo, notification issued thereof, time to time.

The appointed advocates shall submit their joining report to the Law Department immediately after joining along with a copy of Income Tax Pan Card, Aadhar Card, Bank Pass Book, and mentioning his/her Aadhar linked mobile phone number.


They shall also be entitled to clerkage of one clerk, subject to actual appointment of such licensed clerk, the joining report of whom shall be submitted to the Law Department along with copy of the Advocate Clerk's license, Income Tax Pan Card, Aadhar Card, Bank Pass Book, and mentioning his/ her Aadhar linked mobile phone number.
